2. Executive summary

2.1.General progress

In general, the project is delayed against the foreseen in application.

Actions A (*Implementation actions*) are delayed, due to the low interess of national volunteers in this subject and to the welcoming delay to joint volunteers (A.3).

Actions B (Actions for communication and awareness raising) are also delayed, namely the website (still inactive), the communication plan definition and Networking. The necessary process to welcome the first volunteers was more complex and longer than foreseen. This forced the partnership to give priority to the recruitment of volunteers and stabilization of the volunteering program, consequently delaying the remaining actions.

Actions C (*Project management and monitoring of the project progress*) are globally progressing as foreseen.

2.2.Assessment as to whether the project objectives and work plan are still viable

Despite the problems found, 44 volunteers have already been welcomed until the end of November. In the application, the volunteering period was foreseen to have fixed periods. With the project progress the volunteering period was authorized to be between 2 to 12 months. To a more reliable comparison between the foreseen in application and the executed, a calculous was made based on the total number of months accomplished by volunteers instead of the number of volunteers. Based on this calculation, the volunteers received, until now, represent 19% of the total foreseen in application. The first volunteer was received on the 19th of March 2018. From the total of 44 volunteers received, 5 ended their volunteering period before the period agreed on their LIFE VOLUNTEER ESCAPES agreement, being job opportunities given to these volunteers the main reason for the renunciation.

The volunteers have been scalating the management conservation works, either with direct work or by stimulating/promoting activities with the beneficiaries, helping also as monitors. In addition, the work between the beneficiaries has allowed to optimise the complementary goals of each association, for example the joint volunteering actions between Plantar uma Árvore and Montis.

The volunteers have been in contact and in communication with local communities. Efforts are being made to improve and reinforce these componentes in the beneficiaries, such as Rota Vicentina, leading the volunteers into doing environmental education in the community, or as Montis, that in October made a volunteering action with ASSOL (an association that works with mental and physical handicaps) supported by our volunteers. Marca ADL volunteers had an easier contact and communication with the community as the volunteers from this beneficiary come from Montemor-o-Novo Municipality (city where the beneficiary is based). This, increased the number of volunteers mobilized, either for activities or to the project itself, and also promoted a higher disclosure of the environmental problems worked at a local level.

2.3. Identified deviations, problems and corrective actions taken in the period

The lack of available information felt inicially, had some repercussions to the delay of the execution of some actions. The several problems found with the PASS platform, led to the finding of alternatives ways to contact (e.g. e-mail) directly with the PASS platform volunteers. Consequently, the lunch and closing of offers was made directly with each one of the volunteers. It is to highlight that a disclosure outside the platform for the project has been made and the possible volunteers are posterily forwarded to register at the PASS platform. Although this system as been more time consuming, the logistics associated to this have demonstrated to be functional. The problems with the platform already led to the loss of one volunteer and discontent of others. It has been frequent to send an offer to a specific volunteer and despite the volunteers' acceptance of this offer, the PASS platform does not assume the acceptance. This may leed to some volunteers exercising their volunteering period without an accepted offer.

A great difficulty was felt in recruiting national volunteers. Those showing less availability and interest to participate in the project for long periods of time, leading to the extension of the offers to international volunteers, with EASME acknowledgement. It is to highlight that, after this change, the volunteers welcoming process accelerated considerably. Due to the lack of adhesion from the volunteers to periods longer than 6 months, and with EASME acknowledgement, a change to the volunteering period was also made, extended this from 2 to 6 months.

It was foreseen in application that the elaboration of the Individual Volunteering Plan was to be done between the first and the second quarter of the project. However, it was decided to elaborate an editable template that is adapted according each volunteer characteristics. This change, has been beneficial to obtain a higher flexibility to different situations that are emerging.

The APA-ARH beneficiary had some problems with administrative procedures arising from its nature as a public entity, mainly with expenditure framework, hiring processes and goods acquisition. These problems resulted in delays to volunteers' payments, to description sheets of the intervention parcels and staff hiring.

As already informed to NEEMO the excel LIFE_financial_reporting" that is being used to expenditure register was adapted from TOOLKIT LIFE model, since a financial model specifically adapted to the foreseen categories in application, mainly regarding the categories F6.A and F6.B was not provided.

An application error was detected in action A.9, corresponding to the beneficiary Rota Vicentina. Despite being defined in the written section that the beneficiary will welcome 12 volunteers, in the financial section there is only funds for 8 volunteers. Work will be done to reach the maximum number of volunteers considering this error.

3. Administrative part

Contrary to the foreseen in the application, a need was felt to hold monthly presential coordination meetings, to ensure a better operation of the project partnership and to secure the evolution of the project, since it is a preparatory project and some beneficiaries are inexperienced in dealing with LIFE. The meetings have been held alternating between the intervention locals of the beneficiaries to allow a better knowledge of the intervention areas and tasks to be performed by the volunteers. As the partnership is now consolidated, in the future, in order to reduce costs and time spent with trips, the presential meetings will be alternated with web meetings. The possibility of having meetings every 2 months, after a greater stability with the project execution is being considered.

There have been some difficulties from the beneficiaries, regarding the administrative and financial parts inherent to LIFE. Montis has held extra meetings destined to improve those aspects.

In order to facilitate the project management, Montis has created a virtual cloud were all the administrative and financial archive of the project is loaded, with access to all beneficiaries.

In November, the Project Manager of the coordinator beneficiary Montis has left the project. To solve the situation, Montis as ascended the Assistant to Project Manager, being the person with more knowledge of the project. A new technician was hired to the Assistant position. Despite the new manager being full-time, the current solution has not increase the general and personnel costs made by Montis.

The beneficiary Rota Vicentina, has changed the technician in the position of Management and Coordination. This change has not affected the action.

At BCSD, there was also a change in the project team. The person associated to the project in the position of *Adviser* as left the association, whereby, another person has entered to perform the same functions.

4. Technical part

4.1. Progress per action

A.1 Co-Definition of Joint Volunteering Program and Preparation of Individual Volunteering Plans

State: On course

Foreseen start date: 1/01/2018 Actual start date: 1/01/2018

Foreseen end date: 30/06/2018 Actual (or anticipated) end date: 31/03/2020

The action has suffered changes regarding the Individual Volunteering Plan (IVP) and is delayed relatively to joint volunteers.

It was foreseen in application that all IVP's would be done until 30/06/2018. After the start of the project this was found to be imposible to do, mainly due to the speficity needed in adapting each IVP's to each volunteer profile and to the irrgularity with the volunteers' arrivals. Thus, it was decided in a project meeting to produce the IVP's as the volunteers arrive to the entities. It is to highlight that aside from this measure, an "Volunteer Agreement" was produced, describing the rights and duties from the volunteer to the entity and from the entity to the volunteer. The corresponding IVP is attached to this agreement.

Resulting from this decision, the two *milestones* of action A.1"Approval and Public Deployment of first package of Individual Volunteering Plans", foreseen in application for 31/03/2018 and "Approval and public deployment of all Individual Volunteering Plans concluded", foreseen for 30/06/2018, will only be possible to achieve at the end of the project, with the reception of all volunteers. At the end of the project, all IVP's produced during the application will be compiled and sent with the respective report.

Until the end of November, 47 IVP's were produced, being 3 of those IVP's Montis volunteers that are not yet in the project.

To produce and manage the Individual Volunteering Plans, 4 meetings between the beneficiaries were held.

It is expected for all the IVP's to be done by 31/03/2020, since the last volunteers to be received will refer to action A.9, Foreseen to end at 30/09/2020.

Regarding the joint volunteers, the action has not started yet. Due to delays with the volunteers' reception, it was decided to give priority to actions A.4 and A.11, obtaining the necessary knowledge to manage this action. This decision was agreed by all the partnership.

The produced IVP's until this date correspond to 27%, if the 175 IVP's foreseen in application were produced.

All the produced IVP's until this date are annexed to this report on "Annex I – Individual Volunteering Plans".

A.2 Updating Information on Concrete Conservation Areas and Detailing Conservation Activities/Tasks

The action is globally completed, although the main deliverable is delayed for lack of information from one associated beneficiary.

Until the date of 8/06/2018 all beneficiaries collected and compiled the necessary information to the development of the action, except for the beneficiary APA-ARH Algarve.

The delay with the preparation of characterisation files for the intervention locals of the 16 counties of Algarve by the beneficiary APA, mainly regarding the "Descrição sintética dos Valores de conservação de cada parcela operacional", is due to a set of difficulties found in obtaining support for necessary documents from ICNF (Forest and Nature Conservation Institute). Thence, this beneficiary was only able to provide incomplete information on its operational plots, thus making still imposible to finish the deliverable "Action Report (including maps with operational, synthesis description of values in each plot and proposed tasks/activities for volunteers)" foreseen to be delivered for 30/06/2018. The deliverable is expected to be ready on the first quarter of 2019.

The first document prepared (with information provided by APA-ARH Algarve) follows in annex to the report, on "Annex II – Action Report".

A.3 Joint Volunteering Program for integration of ESC with nature and biodiversity conservation

State: iniciated

Foreseen start date: 1/07/2018 Actual start date: Foreseen for the 1° quarter of 2019

Foreseen end date: 30/03/2020 Actual (or anticipated) end date: 30/03/2020

The action was scheduled to start at the beginning of July 2018. However, until now there has not yet been a joint volunteer, and therefore the start of the action is excepted to start with a 6 months delay (the milestone "Welcome to first volunteers", foreseen for 1/07/2018 was not achieved yet). Taking in account the problems already reported with the PASS platform, the project beneficiaries decided in a meeting to give priority to the reception of non-joint volunteers (Actions A.4 and A.11). Reinforcing with this, the recruitment and reception of the volunteers before introducing the joint component.

Currently, with the experience gained with the welcomed volunteers and their integration, it is foreseen for this action to start soon, since two volunteers (in Montis) have manifested their interested to become joint volunteers.

A.4 Volunteering for awareness-raising on natural capital protection, conservation and enhancement

State: on course

Foreseen start date: 1/07/2018 Actual start date: 01/08/2018

Foreseen end date: 30/06/2020 Actual (or anticipated) end date: 30/06/2020

The action is globally delayed.

Regarding action A4.1 "Volunteers selection, recruitment, preparation and training and monitoring", the first volunteer has started his activity on 1/08/2018, with one month delay relatively to the expected (*milestone* "Welcome to first volunteers" was foreseen for 1/07/2018). The delay was due, mainly, to the low number of volunteer applications received, which led to the necessity of increasing the period to receive applications, and to the fact that the volunteer in question was only available after August 2018. This means action 4.1 is a work in progress, which is mainly on the training and monitoring phase.

Action A4.2 "Working plan development" is also a work in progress, because even though only 11 sessions with schools were carried out until now, currently there are more than 40 sessions scheduled from January until March, and the rest of the actions will soon be scheduled.

Action A4.3 "Good practices sharing sessions among companies and their stakeholders" and Action A4.4 "Awareness-raising sessions for young entrepreneurs, start-ups and SMEs" will be initiated in 2019.

Regarding A4.5 "Awareness-raising sessions for secondary students", as referred before, were done 11 sessions on 2018, and nearly 40 are scheduled for 2019.

The *deliverable* "PPT Presentation about natural capital for students (A4.5)" was finished in the schedule presented in the application (30/09/2018). The *deriverable* can be found in Annex III - PPT Presentation about natural capital for students. It is expected that the *deliverable* "Brochure about natural capital for business (A.4.4)", foreseen to 01/05/2020, will be finished by 31/01/2019, 15 months before the foreseen in the application.

A.5 Volunteering Activities for Green Infrastructure within the Municipality of Montemor-o-Novo

State: on course

Foreseen start date: 1/07/2018 Actual start date: 12/04/2018

Foreseen end date: 30/06/2020 Actual (or anticipated) end date: 30/06/2020

The action is globally advanced.

The recruitment of the first volunteer happened at 12/04/2018 and during the rest of April and during May, 4 more volunteers were recruited. The works regarding the maintanence of Marca nursery began with the volunteers' arrival. After authorization from Montemor-o-Novo Municipality the volunteers work has started in the intervention areas under management or

owned by the municipality. The work, focused on IAS control started in May 2018, specially in the surrounding area of Castelo de Montemor-o-Novo. The IAS control in this area was interleaved with the surrounding area of Nossa Senhora da Visitação and Monfurado. On the same areas and after the first period of IAS control was concluded, plantation of native species was performed.

In an early stage of the project it was decided to do, together with the volunteers, an analysis of the different areas previously flagged as IAS control areas. In these field trips contacts with the different land owners were also established focusing in creating awareness of the IAS issue between the owners and requesting permisson to intervened in their lands, committing to provide native plant species to reflorest these areas.

With these interventions, 2,586 ha of IAS area was controlled, in an urban perimeter (Buffer Zone), excluding the Rede Natura area, in which 1.712 ha correspond to Acacia sp. areas.

At the same time, tasks were done that allowed the rehabilization of small sections of water courses. These tasks included, control of *Arundo donax* and implementation of natural engineering techniques, promoting then the settlement of native flora and stabilization of water courses banks.

Some time was spent in seed collection, seeds sorting, seeding and seed/plant transplants. These works were developed to ensure the propagation of the amount of native flora needed for the restoration of the intevention areas. These processes also supported the works foreseen in LIFE LINES.

The control of IAS's is not as advanced as excepted, not only due to the time spent with the plant propagation but also due to the technique adopted for IAS control, particuraly regarding Acacias. The adopted technique – *Acacia* ring barking of individuals with a diameter greater than 5 centimeters (representing 80% of the selected areas) – can not be used through the whole year. This technique requires an optimal season with mild temperatures and high atmospheric humidity, contrary to the hand pulling technique being used in the remaining inidividuals. Thus, it was not possible to apply the ring barking technique between August and October, foreseeing that the same may happen between December and February. For this, it was only still possible to intervene around 1 ha of the Rede Natura IAS, due to the mentioned constraints.

A.6 Volunteering Activities for improvement of nature and biodiversity conservation in private land

State: on course

Foreseen start date: 1/07/2018 Actual start date: 19/03/2018

Foreseen end date: 30/03/2018 Actual (or anticipated) end date: 30/03/2018

The action is globally elapsing as expected.

The first volunteer was welcomed at 19/03/2018, 4 months before the foreseen (*milestone* "Welcome to first volunteers" foreseen for 1/07/2018). Until the end of November, Montis welcomed a total of 8 volunteers. These volunteers correspond to an estimate of 5 volunteers if the volunteering duration foreseen in application was kept at 6 months. Which indicates that this action is below the expected, since the foreseen, until this date, was to welcome 7 volunteers.

From the 8 volunteers, 1 has left the project LIFE VOLUNTEER ESCAPES before the agreed volunteering period. The volunteer was in the project more than the two compulsory months and for personal reasons has decided to leave the project.

All the volunteers have been developing tasks in the different areas managed by Montis contrary to the model of 1 intervention area for each volunteer. This model of intervention in the different areas is more enriching to the volunteers, as they can experience and learn different problems and solutions to all the areas. It also allows a better adaptation to the real needs and priorities of each managed property. Until now, the volunteers have already perfomed conservation actions in 4 properties managed by Montis: Carvalhal de Vermilhas, baldio de Carvalhais, Costa Bacelo and Valadares. These conservation actions covered 2 ha of Rede Natura 2000 "Serra das Freita e Arada" (PTCON0047) and "Rio Paiva" (PTCON0059) areas. Despite this value is relatively low, it is expected for it to substancially increase during 2019.

These interventions include the supporting of natural regeneration (though pruning and reduction of biological competition – shrub cut), use of natural enginering techniques (such as gabions and palisades), plantations of autochthonous trees, IAS control (mainly *Acacia spp.* e *Hakea spp.*), opening and maintenance of accesses, ecological monitoring and direct seeding. Apart from these tasks, the volunteers were also involved in other conservation activities or complementary, developed by Montis.

The indicators regarding the number of local volunteers involved in activities with the ESC volunteers were achieved and overcomed.

The indicators regarding the new job positions created within the project, with a view to be maintened after the project end, were achieved and overcomed.

A.7 Volunteering Activities for nature conservation within the Municipality of Torres Vedras

The first volunteers started at 06/11/2018, with a 4 months delay from the foreseen. The problems with the PASS platform were attempted to be overcomed by the disclosure of the volunteering offers through other platforms, such as the Municipality Local Volunteer Bank, Youth Area, Facebook, the Municipality website, highschool, profissional and universities

contacts and e-mails. Through these channels it was possible to reach young people from the region interested in making part of the project as volunteers.

The 3 volunteers received for the period of 6 months each, have been supporting not only the production of autochthonous species in nurseries and with plantantions of dune flore with collaboration of the school students from Torres Vedras county, but also with plantantions of other autochthonous species in lands of the municipality.

So far, it was not possible to quantify the habitat protected areas of the Habitat Directive and the area intervened with IAS control, mainly the removal of *Carpobrotus edulis* in Praia Azul dunes (in collaboration with LIFE volunteers and students from the county) as these activities occurred very recently.

Within the LIFE Volunteer Escapes the beneficiary Munícipio de Torres Vedras intends to carry out, among other actions, work for the habitat maintenance/conservation of Ruivaco-do-Oeste (*Achondrostoma occidentale*), an endemic fish species from the Sizandro and Alcabrichel rivers. These works are yet to be iniciated as the activities can only start after the works in the habitat restauration of Ruivaco-do-Oeste (*Achondrostoma occidentale*) are concluded. The work for the restauration of this habitat are being executed within the project financed by POSEUR. The works in this project are expected to take place until April 2019. After concluded, complementary maintenance actions will be perfomed by the LIFE project volunteers, as foreseen in application.

The land owners' enrolment in conservation activities has yet to start.

The preparation and launch of the project website are currently with a 6 months delay as the website is yet to be done. The preparation for the production of this episode started in June 2018 with a meeting held between the beneficiaries PlaySolutions and BCSD in June 2018, to define the video guide structure. The necessary images were already collected as well as some testimonies. An approval by the beneficiary BCSD of the video guide in order to start its edition and conclusion is currently awaited. The episode is expected to be finished by 31/01/2019, with a total of 4 months delay to the foreseen in application, the *deliverable* "TV Series – episode on "Business and Natural Capital" scheduled for September 30th 2018. It is to highlight that this *deliverable* was associated wrongly, in application, as it was associated to action B.2 instead of B.3.

The first project coordination team monthly meeting was held in 11/01/2018 achieving the *milestone* "First Meeting of the Project Coordination Team concluded" scheduled for 31/01/2018. Currently, 9 monthly meetings were already held, from which 8 were presential monthly meetings, and only the last one held, at 22/11/2018 was done by Skype. The monthly meetings have been ensuring a better coordination of the team and administrative, technical and finantial management of the project.

Apart from the project general management meetings, several other presential meetings were held, according to the beneficiaries' availability, to discuss and ensure the financial and administrative management of LIFE.

The Stakeholders Advisory Board was received in 26/09/2018, achieving the *milestone* "First Meeting of the Stakeholders Advisory Board concluded", forseen for 31/01/2018. The meeting was held during the SEIVA event, organised by APA-ARH Algarve, which was open to the general public and allowed the disclosure of the project, the exchange of ideas and experiences between the project beneficiaries, the Stakeholders Advisory Board and the public. 

4.3.Impact

Although it is still early to withdrawal conclusions, since the project still only has a year of development, the general evaluation done by the partnership seems to be of a positive impact. The ESC volunteers, have allowed to improve/promote the conservation actions developed by the beneficiaries and have also demonstrated to be a great asset to the enrolment of local communities. The feedback given by the volunteers, until now, have been positive. In future reports the project impacts will be evaluated and substantiated detailed.

4.4. Outside LIFE

Since its creation, Montis has been integrating the community in the nature management and conservation, using volunteering as central tool to this goal. The project as reinforced, consequently, this vast experience with the integration of long-term volunteering. Longside, the association has in execution another project, LIFE ELCN. The pilot action of the project aims to the use of crowdsourcing for nature conservation in private lands, with an equally specific volunteering program.

The beneficiary SPEA receives EVS volunteers reguraly and interns, promoting the experience exchange between these volunteers and the ESC volunteers. Furthermore, and outside this LIFE, SPEA develops other volunteering actions (short duration) on the 3 intervention areas, targeting different audiences (companies, local population, associates). These actions complement the work associated with this LIFE project and acts as one more opportunity to disclosure the project actions.

The beneficiary Marca ADL has reguraly on course diverse projects, that whenever possibly seek to relate social and environment areas by: receiving volunteers from the European Voluntary Service (EVS), taking part in partnership created by Erasmus +, organising internacional workcamps and youth volunteer activities at national level and creating tourism activities of creative nature.

Finally, this partnership has allowed to create and promote collaboration opportunities between the beneficiaries (e.g SPEA and ARH-Algarve), apart from the ones included in this LIFE.

The overall costs incurred until the end of September are lower than expected, and the total percentage of budget spent so far is 6,25%. This low rate is related to the delay in some actions, reflected mainly in categories 3 ("External Assistance") and 6 ("Costs for volunteers" and "Invidivual or organisational support for volunteers"). For external assistance weight, apart from the action's delays, delays in hiring, particuraly in the case of public entities such as APA-ARH Algarve. On category 6 weighs the delay in the reception of the first volunteers. Other detailed financial matters, including doubts, will be presented in annexe VIII.
